I declare that I meet the access requirements for a professional training in Expressive Art Therapies. If necessary, I agree to accomplish what I miss before graduating in Dmt. I declare that I have been informed about all that follows and I agree completely with that.

1. Dmt is an art and social profession, developing the creative potentialities of individuals and groups. It can be used in Health Care, as a complementary side resource, only under responsibility of Medical Doctors and/or of Psychologists.
The management, the teachers and the students of the School trust the Italian Professional Association ARTE and other international Art Therapies Professional Organizations, whose ethical codes they observe. The students allow the School to share their full names and the titles of their thesis with the Professional Organizations.
Dmt Practices will be developed in other institutions, according to specific agreements. Any students' other Dmt-like activity is not responsibility of the School, is not acknowledged and could even cause exclusion from the training.
All information got during training activities are submitted to the privacy ethical and legislative constraints. Papers respect the anonymity of mentioned subjects. Training activities could be video recorded, and such recordings could be diffused for scientific or promotional purposes of the Association.
2. Here the fees for 2020:
 - € 100 as annual registration fee, including membership in the Association, insurance, exams, secretary services, reserved rates for training activities, access to the private area of www.danzaterapia-esprel.it website.
 - € 280 for each 32 hours training workshop.
 - € 70 for each 7 hours Supervision Seminar
 - The fees due to other institutions for workshops, supervision and for any activity acknowledged by the School.The fees do not include other activities, travel, food and accommodation costs, books and any other expense not indicated above. The nonpayment can imply the exclusion from training activities and exams. In the case of non-agreed cancellations, of absences, or of exclusion for serious reasons, no contributions paid will be returned. The School Management could change the schedule; all Training info will be published on www.danzaterapia-esprel.it website.
3. Training classes in Italy will be held ordinarily in Italian language. There will be no professional translation service, but teachers and students will translate into English what necessary, within the limits of their language skills.
Students commit in attending the whole required amount of hours, particularly: 320 hours of Training workshops (only if managed either acknowledged by the School), 100 hours of Supervision in Dmt (with professionals suggested or acknowledged by the School Management), 160 hours of Dmt experiential workshops (at least 50% of which with Dmt-ER® professionals). Students undertake to participate actively in training activities, in compliance with its functional performance and of all the involved partners. Students also conform to the unquestionable judgment by who will be in charge of carrying out examinations.

4. Final exams take place once a year in Rome. Not Italian students can discuss their thesis by videoconference and take all other exams in ordinary sessions held in any Country. The eventual participation to extraordinary exam sessions, set at the request of at least three students, requires an individual supplementary fee of € 100. Thesis can be discussed within an academic year after accomplishing all the required hours. Beyond this deadline, an exam fee of € 100.00 is required and educational supplements may be required too. After more than five years, the training course lapses, but could be assessed in part as credit.

Privacy Information pursuant to the European Regulation nr. 679 of 25 May 2016 (GDPR).

We inform that **DANZARE LE ORIGINI - Associazione di Promozione Sociale**, placed in via Nairobi 40, 00144 Roma (RM), Italy, fiscal code 97842600583, in the person of the legal representative, as **data controller**, processes your personal data, with **manual and electronic tools**, for the following **purposes**: a) for the management of your negotiating relationship in each phase (pre-contractual, contractual, litigation, etc.) as well as for the fulfillment of legal obligations; b) for scientific, informational and promotional purposes of the Association.

The provision of data processed for the purposes referred to in point a) (by way of example, identifying data such as name, address of residence and domicile, e-mail, telephone numbers, etc.) is necessary for the fulfillment of contractual obligations and for the fulfillment of legal obligations.
