SETTING

Online activities

Requirements: good Internet connection, laptop (no mobile telephone). Personal space well-lit and quiet, suitable to move on the floor and standing (no cars, no outdoor space if without privacy, no other people present in the same space). Clothes colors contrasting to the background. Video on, all the time. Participants who would switch off their cameras, or would not follow the rules above, will be excluded from the sessions.

For supervision, cases must be proposed through the enclosed form, that will be updated from time to time and shared with the whole group.

For the theoretical seminars, each topic will be developed starting from the preliminary study of texts provided by the Dmt-ER® School, then discussed in small groups and in plenary session.

Live activities

Workshops, anywhere held, must be attended from the beginning to the end, with no absences, that would interfere with the group process and would damage the individual learning. It must arrive on time; in case of unintentional delay, it must wait for the next pause to get in.

Depending on the pandemic situation, procedures and devices of public safety (masks, tests, green pass...) will be adopted, according to the hosting Countries rules. Activities in Egypt will be led in English. For activities in Italy led in Italian, a not professional English translation will be provided.

EVALUATION

Exam

For interested students, an exam session will be scheduled before summer, in May in Cairo, if there will be only a little number of exams. Otherwise, the session will be scheduled online later.

Thesis Defense

A session of Thesis Defense in English will be scheduled, when useful for at least three participants. Remember that to be admitted to the thesis defense it should have accomplished all debts. The pdf (no more than 50 pages) must be sent at least 30 days before the session.

In Italy usually we admit also if a small number of hours is missing (5% of the training and supervision amount, so 21 hours at most). Considering your particular situation, we would allow for this year a wider exception for you, but, in any case, not over the number of credits a student can realistically get in one year. So, it is time to check your logbooks; excuse me if in Cairo I have not been precise as necessary, but we had a short time, for so many logbooks! We'll do it better in the next weeks.

In any case, even after having discussed the thesis, <u>the certification will be released only after having</u> <u>accomplished all the required didactic hours</u>, i.e. 320 hours of Training, 100 hours of Supervision, 160 hours of Experiential Workshop.

Certification

Our certification is compliant with the Italian UNI standard (11592:2015), acknowledged by APID (Italian DMT Professional Association) and EADMT (European DMT Association, of which APID is member). Our program satisfies the international EADMT standards.
