The undersigned declares to satisfy the requirements for access to training in arts therapies and undertakes to make any necessary additions before obtaining the certification. The undersigned also declares not to be concerned by any ethical issues in conflict with the DMT training and profession. The undersigned also declares to be informed of all the following and to adhere to them in full.

- Dance Movement Therapy (Dmt) promotes health through creative processes. It can be used as adjunctive 1. complementary resource in the clinical field only under responsibility of Medical Doctors and/or Psychologists, according to the laws / rules depending on each Country.
- The Management, the teachers and the students refer to the Arts Therapies professional associations and 2. observe their ethical codes. The students agree in transferring to professional associations their generalities and the titles of their theses.
- Each student undertakes to attend a number of hours of onsite training at least equal to the number of hours З. attended online. Online hours more than onsite hours will not be acknowledged.
- Practice will be held at other Institutions, according to specific agreements, under supervision. The School 4. has no responsibility for any Dmt activity managed by students not planned in supervision, that could cause exclusion from the program.
- Students are not allowed to use the title of dance movement therapist or similar in any context, before 5. being certified. Students cannot use the Dmt-ER[®] brand or the term "Relational Expressive DMT", unless in strict reference to the school they attend. Failure to comply with the above leads to disciplinary measures, from a simple warning to exclusion from the program.
- All information learned during the training activities are confidential. The papers respect the anonymity of the 6. subjects mentioned. The courses can be videotaped and the images can be spread for scientific, informative and promotional purposes of the School.
- Activities will take place face-to-face and / or remote, also depending on the governmental provisions for the 7. fight against the Covid19 pandemic. If a course should be suspended or interrupted for health reasons, the students enrolled will have the right to participate in the next course without any further economic burden. In no case fees paid can be refunded.
- The fees for 2024 are: 8.
 - ONLINE ACTIVITIES: € 600 (even by installments), including 32 hours of Training seminars, 16 hours of group supervision, 2 individual supervisions, exams, login credentials for the website www.danzaterapia-esprel.it.
 - ONSITE ACTIVITIES: according to the fees set by the organizations managing the training activities.

The fees for 2024 activities in Italy are as follows. 32-hours Training Workshop € 280. 14-hours Weekend € 130. Group supervision: € 10 / hour. Individual supervision: onsite € 30, online € 20. Experiential workshop: €25/2hrs, €30/4hrs, €50/8hrs, €70/12hrs, €90/16hrs. Fees for other activities as per brochure. The fees above do not include travel and accommodation expenses, books and anything not expressly indicated.

In the event of absences or exclusion for serious reasons, the refund of contributions paid is not provided. If not authorized by the Management, waivers of activities scheduled in Italy involve the payment of 25% of the fee if communicated at least 20 days in advance, of 50% if communicated less than 20 days in advance, of the entire fee if communicated the starting day or not at all.

- 7. Any communication about the program (including changes to the calendar, established unquestionably by the Management) will be published in the reserved area of the website <u>www.danzaterapia-esprel.it</u>.
- 8. Classes in Italy will be ordinarily held in Italian, with some translations in English provided by the trainers. No professional translation will be provided. Online classes and supervisions in English will be provided. Courses in English held and managed by other Institutes will be acknowledged.
- 9. Without prejudice to the recognition of training credits, the student undertakes to attend the entire number of hours, in particular 320 hours of training, 100 hours of supervision in Dmt with professionals authorized by the Management, 160 hours of Dmt experiential workshops (of which at least half with Dmt-ER[®] professionals authorized by the Management). Students undertake to actively participate in the training activity, respecting its functional development and all the partners involved. Students also abide by the unquestionable judgment of who will be responsible for carrying out the evaluation tasks during the exam.
- 10. Each year the School establishes an ordinary national thesis discussion session and at least one ordinary evaluation session, in which it is possible to sit any exam (except for the thesis defense). Extraordinary sessions can be set up at the request of at least three students, who undertake to pay a supplementary contribution of € 100 each. Foreign students will be allowed to attend any exam session from remote. The discussion of the thesis is subject to the fulfillment of all formalities, attendance obligations and exams, and usually takes place within the academic year following the conclusion of the curricular process. Beyond this deadline, educational additions and an exam fee of € 100 are required. If the thesis has not yet been discussed after 5 years from the completion of the training process, this last decade, but it can be assessed as a credit at the discretion of the Management.
- 11. The School has the right to withdraw by written notice by registered letter (or certified E-mail, where present) to the student if, for any reason, it ceases its activities or due to force majeure. In this case, the student will not be required to pay for the period of non-use of the period not enjoyed.
